It is further understood and agreed that any and all movements will be made in the manner provided by law, and in accordance with the conditions and regulations as hereinafter set forth, all forming a part hereof, in which the applicant agrees in the acceptance of this permit to assume all responsibility and liability for damages to persons and/or property that may accrue during the movements of the vehicles or combination of vehicles, through the negligence of himself, his agents or employees, or from any other cause and to save the County of Genesee harmless therefrom.

SPECIAL HAULING PERMIT

Authorizing the movement over County Roads/Bridges of a vehicle or combination of vehicles, the dimensions and weights of which, including load, exceed those specified in Section 385 of Vehicle and Traffic Law.

PERMISSION IS HEREBY GRANTED

To _____, whose principal place of business is at _____

to operate or move the vehicle or combination of vehicles with load, as hereinbefore described, the weights and dimensions of which exceed the limitations provided for in Section 385 of the New York State Vehicle and Traffic Law, over certain County Roads/Bridges listed as follows, between the aforesaid points and the dates as indicated when roads and weather conditions are favorable.

Points of Travel of Vehicle indicated by the following County Roads:

Period of time from _____ to _____ daylight hours only, with no movement on Saturdays, Sundays or Holidays.

Operations must be conducted, in-so-far as it is possible, to permit safe and reasonable free travel whereby all safety provisions for the movement of such traffic shall be provided by the permittee. Red warning flags, size 24 inches by 24 inches, shall be carried to warn and protect traffic, as an indication of oversize load moving.

In moving over any narrow section of highway or bridge, where for any reason it is impossible to keep free and clear at least one full lane of pavement for passing traffic, each movement over such sections shall be accompanied by flagmen, stationed at least 300 feet ahead and 300 feet following such vehicle so as to warn and protect traffic. Clearance must be checked on all bridges and rail crossings and where there are weak or load posted bridges a detour must be made.

It is understood and provided that this permit shall apply to County Roads/Bridges only.

Overhead wires, cables, signal or traffic lights, limbs of trees, or overhead structures must not be disturbed, without first obtaining permission from the owners thereof. If the height of vehicle, or combination of vehicles and load exceeds 13 feet-6 inches, movement shall not be stated until consents have been obtained from said owners.

In the acceptance of this permit, the applicant further agrees to assume all responsibility and liability for damages to persons or property that may accrue during said movement of the vehicle, or combinations of vehicles, through the negligence of himself, his agents or employees or from any other cause and to save the County of Genesee harmless therefrom. Each instance of movement of vehicle, or combinations of vehicles, shall include insurance coverage of \$2 million of general liability coverage as evidenced by a Certificate of Insurance.

This permit is issued pursuant to the authority conferred upon the County Highway Superintendent by Article 10, Section 385 of the New York State Vehicle and Traffic Law, which provides among other things, that all permits issued shall be revocable by the authority issuing them at the discretion of the said authority without a hearing or the necessity of showing cause, either before or during the movement.
