

**ELEVENTH DAY  
GENESEE COUNTY LEGISLATURE  
Batavia, New York  
Wednesday, June 13, 2012**

The Genesee County Legislature met in Regular Session on Wednesday, June 13, 2012 at 7PM at the old Courthouse, 7 Main Street, Batavia, NY. Prayer was offered by Legislator Leadley followed by the Pledge to the Flag. Legislator Cianfrini was absent.

Legislator Stein assisted with the reading of a Proclamation, National Dairy Month which was accepted by members of the Dairy Princess Court who distributed ice cream to all in attendance. It was noted that this is a favorite meeting of the year, and everyone looks forward to the arrival of the Dairy Princess and her delicious treats. Legislator Stein noted that the Ag Park celebrates Ag in Genesee County and the future is cemented for the dairy industry for the next 50-75 years with the improvements planned.

The minutes of the May 23, 2012 meeting were approved upon motion of Legislator Lawrence seconded by Legislator Stein.

Legislator Stein reported that the GCEDC held an informational meeting with Cayuga County Officials who were interested to learn about shovel ready parks with a long term view towards development. Mrs. Stein noted that the GCEDC Board has approved 4 new exemptions as part of a busy month, and there are 5 cranes in the sky at the Ag Park. Chair Hancock noted she appreciated the new format of the GCEDC Exemption notice and found it easy to read and understand. Legislator DeJaneiro stated he sat in on a Conference Call with the Genesee and Orleans County Board of Health and State Board of Health to discuss the shared Director possibility. He attended a Quality Assurance Meeting at the Nursing Home and there were three Legislators present at that meeting. The DOH survey and other matters were discussed. Administration will be doing some strategic planning for the future. Legislator Clattenburg stated that Planning Board has the STAMP Project on its June 14, 2012 Agenda. Legislator Leadley stated she was frustrated by the no urgency response to the continued pleas of the Counties for Mandate Relief. She just doesn't know how to shake it up. Chair Hancock noted that she attended meetings in Albany with many counties being represented and was alarmed to learn that some counties have been contacted by Moody's with a statement that because they are New York counties and under the Tax Cap, there is concern that they will not be able to meet bonded indebtedness obligations. The perception is "that counties must try harder to rein in spending."

Legislator Stein thanked everyone for their interest and participation at the LeRoy Bicentennial Celebration. Legislator Leadley noted that the Pomeroy Foundation donated the marker for the celebration and they were very complimentary about the event. Sometimes they arrive for a dedication and no one else is present. They commented that LeRoyans know how to celebrate!

Congratulations were offered to the Notre Dame Girls Softball team for bringing home the State title. Officials at the game are said to have commented that they have never seen "such class" during a close final game. Winning is wonderful, but the notice of behavior is worthy of celebration also. The Clerk was asked to prepare a Proclamation. Chair Hancock noted the Stafford Carnival is being held this weekend and a MEGA meeting is being sponsored on June 14, 2012 at the Fire Training Center.

Chair Hancock reported she attended the Regional Economic meeting and there is

a good bit of competitive funding available. The County applications received an evaluation of the strategic plan with several suggestions on how it may be improved. STAMP was mentioned favorably as a project. Chair Hancock gave the Jobs Report citing 432 job openings. May Unemployment figures are not yet available but Genesee County appears to be down by 300. The range of jobs listed is very diverse.

The Clerk proceeded with the reading of the resolutions:

**RESOLUTION NO. 221 CONTRACT/BUDGET AMENDMENT – NURSING HOME/MDS CONSULTANT – APPROVAL OF**

Legislator DeJaneiro offered the following resolution:

**WHEREAS**, The Genesee County Nursing Home seeks to hire a professional consulting service to provide training and development of staff skills with the Minimum Data Set (MDS) in an effort to ultimately increase Medicare and Medicaid revenue at the Nursing Home, and

**WHEREAS**, Genesee County did issue a Request for Proposals for such services and one response was received, and

**WHEREAS**, The proposal was reviewed and the Nursing Home Administrator does recommend the award of services to MDS Consultant, LLC,

**WHEREAS**, The Committee on Human Services did review this recommendation and does concur. Now, therefore, Be it

**RESOLVED**, That the Chair of the Genesee County Legislature is hereby authorized and directed to execute a contract with MDS Consultant, LLC, 137 Rae Drive, Rochester, New York, 14626, in the person of Gloria Brent, R.N., for the purpose of providing professional consulting services and training on the MDS document at an annual cost of \$143,000 effective June 14, 2012 through June 13, 2013 with a one year renewal option upon mutual consent, and Be it further

**RESOLVED**, That the Genesee County Treasurer is hereby authorized and directed to make the following transfer:

**Budget Impact Statement:** Elimination of one full-time Nurse Unit Manager position at a cost of \$83,753. The remaining \$59,247 to be realized through increased revenue from use of these services.

Legislator Lawrence seconded the resolution which was adopted by 298 votes, Legislator Cianfrini (28) absent.

Prior to roll call on the above resolution Legislator Leadley noted that the intent to hire a consultant had to do with a concern that collection of MDS monies has not been as productive as it might be. The recommendation to hire the consultant will result in considerable increased reimbursement. Nursing Home Administrator Schaller stated it is her belief that the NH can do better completing the MDS forms that are required on each patient at least four times per year. Currently these are completed by several people and may not be uniform. One or two nurses doing all could result in \$700,000-\$900,000

additional reimbursement once properly trained and familiar with the new regulations. Part of the proposal to bring on the consultant is to eliminate a vacant Nurse position. This has been vacant for some time and she does not believe it will adversely affect patient care and quality of services, but improve them. The contract does have a termination clause if it does not work out as expected. Legislator DeJaneiro stated that the Human Service report indicated increased reimbursement and training to our staff as benefits. Legislator Clattenburg asked how this will be different from what we are currently doing. Administrator Schaller explained that currently each Nurse Manager completes the MDS forms on their patients. Because of different time schedules these reports were then juggled and managed by an overseer. Often time deadlines were not met because there was not one person accountable for the full process. This proposal would centralize the MDS evaluations and reporting. There have been many changes recently in the information, etc. and the full staff was not up to speed on this. The current MDS coordinator will learn a lot from the contracted agency. The Nurse position being eliminated has been vacant in 2012. The County finds itself in an unfortunate box as reimbursements to county-owned Nursing Homes continue to decline. County Manager Gsell noted that the case mix index has been reduced drastically while our care is far and above the norm.

**RESOLUTION NO. 222 ACCEPTANCE OF COLA/BUDGET AMENDMENT- YOUTH BUREAU/REALITY CHECK-APPROVAL OF**

Legislator Lawrence offered the following resolution:

**WHEREAS**, The Executive Director of the Genesee County Youth Bureau did receive notice of cost of living adjustment to the Reality Check Program in the amount of \$14,035 from the NY State Department of Health and

**WHEREAS**, The Executive Director of the Youth Bureau did request an amendment to the 2012 Youth Bureau Budget to accept said funding, and

**WHEREAS**, The Committees on Human Services and Ways and Means did review the request and do recommend approval at this time. Now, therefore be it

**RESOLVED**, That the Genesee County Treasurer is hereby authorized and directed to amend the 2012 Genesee County Budget by increasing Revenue Account A.1000.7310.3820 – State Aid in the amount of \$14,035 to be offset by an increase in Contractual Accounts as follows

**Budget Impact:** Increase in A7310 of \$14,035 to cover operation of the Reality Check Youth Action Program through December 31, 2012. All expenditures in this program are offset by revenue. There is no net county cost.

Legislator Bausch seconded the resolution which was adopted by 298 votes, Legislator Cianfrini (28) absent.

**RESOLUTION NO. 223 AGREEMENT – YOUTH BUREAU/ RESOURCE ALLOCATION PLAN – APPROVAL OF**

Legislator DeJaneiro offered the following resolution:

**WHEREAS**, The Genesee County Youth Bureau and Department of Social Services

have developed a joint plan to be eligible for state aid from the New York State Office of Children and Family Services under the Child and Family Services Planning Guidelines, and

**WHEREAS**, The Genesee County Youth Board, Youth Bureau and Department of Social Services are desirous of continuing county comprehensive youth services planning efforts during 2012 which includes the allocation of resources to municipalities and community based agencies to the extent said funding is provided by NYS and with no expectation of direct Genesee County appropriation, and

**WHEREAS**, Guidelines provided by the Office of Children and Family Services for applying for said eligibility have been satisfactorily completed by the Genesee County Youth Bureau and the Committee on Human Services does recommend approval at this time. Now, therefore, Be it

**RESOLVED**, That the Genesee County Legislature does hereby authorize the Chair to execute such documents as are deemed necessary to effect the 2012 Genesee County Youth Bureau Resource Allocation Plan and the Child and Family Services Plan with the New York State Office of Children and Family Services.

**Budget Impact Statement** - Resource allocation to contract programs is included in the 2012 department budget. Allocations are completely offset by revenue. Municipal funds are allocated directly to towns/villages and are not included in the county budget. All payments to agencies are subject to availability of state aid.

Legislator Ferrando seconded the resolution which was adopted by 298 votes, Legislator Cianfrini (28) absent.

**RESOLUTION NO. 224 EXTENSION OF CONTRACT – OFA/MEAL PREPARATION SERVICES-APPROVAL OF**

Legislator Ferrando offered the following resolution:

**WHEREAS**, The Director of the Office for the Aging did present the extension of the contract with American Red Cross – Greater Rochester Chapter, for the period of June 25, 2012 – July 20, 2012, for the provision of Meal Preparation Services for Office for the Aging to allow for a smooth transition from our current food service contractor to the new food service contractor; and

**WHEREAS**, American Red Cross – Greater Rochester Chapter has agreed to continue the congregate and home delivered meal preparation and packaging services for the Office for the Aging at rates established through RFP 2007-57, with the same terms and conditions; and the Committee on Human Services does recommend approval at this time. Now, Therefore, Be it

**RESOLVED**, That the Chair of the Genesee County Legislature is hereby authorized and directed to execute the necessary documents to extend the contact with American Red Cross – Greater Rochester Chapter, 50 Prince Street, Rochester, N.Y., 14607, at a cost of \$4.31 per meal for regular home delivered meals; \$7.69 per double home delivered meal; \$4.15 per meal for congregate meals; \$3.38 for congregate/ home delivered sandwich meal; and \$36.45 for Frozen 7 Meal Pack; and an additional cost of \$140 per day for delivery to drop off sites in Genesee County; with a total contract not to exceed \$14,500 for the period of June 25, 2012 – July 20, 2012.

**Budget Impact:** Neutral. The cost of this one month extension is fully covered in the 2012 county budget and is covered by grant funds.

Legislator Leadley seconded the resolution which was adopted by 270 votes, Legislator Cianfrini (28) absent and Legislator DeJaneiro (28) abstain.

Prior to roll call on the above resolution Legislator Leadley stated the contract is being extended to allow the new provider the time necessary to gear up and make a seamless transition. Legislator DeJaneiro stated he would be abstaining because of business dealings with the firm. Legislator Stein asked what the actual cut off date is for the two services. Office for the Aging Director Whitmore said Red Cross will be concluding service on July 20<sup>th</sup> and ARC will begin deliveries on July 23<sup>rd</sup>.

**RESOLUTION NO. 225 CONTRACT RENEWAL- BOARD OF ELECTIONS/PRINTING SUPPLIES - APPROVAL OF**

Legislator Lawrence offered the following resolution:

**WHEREAS**, The agreement entered in 2011 by the Genesee County Legislature on behalf of the Board of Elections with Phoenix Graphics, Inc. of Rochester for printing supplies expires June 30, 2012,

**WHEREAS**, The contract called for an option to renew for four (4) one year renewals during the period,

**WHEREAS**, There has been no change in pricing for the period of July 1, 2012 thru June 30, 2013 and the Board of Elections has been very satisfied with the performance of Phoenix Graphics, Inc. Now, therefore, Be it

**RESOLVED**, That the Chair of the Genesee County Legislature is hereby authorized and directed to enter into an agreement with Phoenix Graphics Inc. of Rochester, NY for the printing supplies for the 2012 Primary and General Election, per bid specifications, effective July 1, 2012 through June 30, 2013 in an amount not to exceed \$16,644.00.

Legislator DeJaneiro seconded the resolution which was adopted by 298 votes, Legislator Cianfrini (28) absent.

Prior to roll call on the above resolution Legislator Leadley noted that the County will now be paying for printing costs and HAVA will no longer reimburse for these charges. County Manager Gsell noted that \$100,000 remains in the HAVA grant. These funds would be available for new or replacement machines.

**RESOLUTION NO. 226 CONTRACT RENEWAL-DSS/OFFICE FOR THE AGING/PERSONAL EMERGENCY RESPONSE SYSTEM (PERS) SERVICES APPROVAL OF**

Legislator Ferrando offered the following resolution:

**WHEREAS**, Resolution No. 184 adopted June 8, 2011 did authorize a contract for the provision of Personal Emergency Response System (PERS) services on behalf of eligible clients of the Department of Social Services and the Office for the Aging, and

**WHEREAS**, Pursuant to Genesee County Request for Proposals #2011-102 it is the mutual desire of the Genesee County Commissioner of Social Services, the Director of the Genesee County Office for the Aging and Medical Answering Services, LLC to renew said contract for the period of one additional year under the same terms and conditions, and

**WHEREAS**, The Committee on Human Services has reviewed this request and does concur. Now, therefore, Be it

**RESOLVED**, That the Genesee County Legislature does hereby authorize and direct the Chairperson to enter into an agreement with Medical Answering Services, LLC, PO Box 11998, Syracuse, New York 13218 for the provision of PERS services to the eligible



Court, Western District of New York, 300 Pearl Street, Suite 250, Buffalo, NY for the use of the Courtroom in the Old Genesee County Courthouse, Batavia, NY for the period October 1, 2012 through September 30, 2013 at \$850 per month for utilities, general liability insurance and maintenance of space.

**Budget Impact Statement:** Extends current agreement at current monthly rate; revenue for period \$10,200.

Legislator DeJaneiro seconded the resolution which was adopted by 298 votes, Legislator Cianfrini (28) absent.

**RESOLUTION NO. 233 MEMORIALIZATION OF SUPPORT-S5629-B/A6575 AN ACT TO AMEND THE TAX LAW, IN RELATION TO AUTHORIZING CERTAIN COUNTIES, CITIES AND SCHOOL DISTRICTS TO IMPOSE UP TO A FOUR PERCENT RATE OF SALES AND COMPENSATING USE TAXES PURSUANT TO THE AUTHORITY OF ARTICLE 29 OF SUCH LAW AND TO PRESERVE THE AUTHORITY OF CERTAIN COUNTIES AND A CITY TO IMPOSE SUCH TAXES AT RATES IN EXCESS OF FOUR PERCENT; AND TO REPEAL CERTAIN PROVISIONS OF SUCH LAW RELATING THERETO**

Legislator Leadley offered the following resolution:

**WHEREAS**, Genesee County strongly supports this home rule legislation as it provides enhanced fiscal management tools for local governments. County and State legislative staff, along with our elected officials, currently spend significant time and energy in order

to deal with the renewals of existing local sales tax rate legislation every two years under the current State legislative model, and

**WHEREAS**, The proposed legislation would end the practice of requiring state approval and renewal for local sales tax rate changes, up or down, that do not exceed four percent. This will allow county officials to manage their local sales tax rates in a way that is most efficient for local tax payers and reduce waste and redundancy in state and local legislative procedure, and

**WHEREAS**, County leaders make home rule requests out of necessity, to finance, implement, and deliver state and federally mandated programs, ensure local public health and safety, foster economic development and enhance local quality of life services demanded by county residents. These home rule requests allow local officials to manage their budgets and pay for state mandated and other services in the least intrusive and burdensome way for local taxpayers and are often requested to limit or prevent property tax increases. This legislation would also provide counties with an important local fiscal management tool consistent with similar financial management flexibility granted to New York City. Now, therefore, Be it

**RESOLVED**, that the Genesee County Legislature supports the passage of S5629-B and A.6575, and Be it further

**RESOLVED**, That certified copies of this resolution be forwarded to Governor Andrew Cuomo, Senator Michael Ranzenhofer, Assemblymen Steven Hawley and Daniel Burling, NYSAC, and InterCounty Association of Western New York.

Legislator DeJaneiro seconded the resolution which was adopted by 298 votes, Legislator Cianfrini (28) absent.

GENESEE JUSTICE/NYS CRIME VICTIMS BOARD  
APPROVAL OF**

Legislator Stein offered the following resolution:

**WHEREAS**, the Sheriff of the County of Genesee did receive notification of the award of grant funding in the amount of \$169,318 from the New York State Office of Victim Services for the continuation of the Comprehensive Victim Services Program and Justice for Children Advocacy Center for a one-year term starting October 1, 2012, through September 30, 2013, and

**WHEREAS**, the Genesee County Legislature did review this request and does recommend approval at this time. Now, therefore, be it

**RESOLVED**, that the Chair of the Genesee County Legislature and the Sheriff of Genesee County are hereby authorized and directed to execute the Agreement with the New York State Office of Victims Services for the acceptance of Comprehensive Victim Services Program/ Justice for Children Advocacy Center funding for the period October 1, 2012, through

September 30, 2013, in the amount of \$169,318, and to execute any and all other documentation related to this funding.

**Budget Impact:** Funds for this grant have already been estimated in the 2012/2013 Genesee County Budget.

Legislator Clattenburg seconded the resolution which was adopted by 298 votes, Legislator Cianfrini (28) absent.

At this time Legislator Leadley noted that the county Manager had not been asked for his report. He replied that a recent meeting with Mark Peterson upped the ante for the Greater Rochester Enterprise. Kodak park will be addressed first and Genesee County's STAMP Project could be next. The advocacy level needs to ramp up and the "bridging region" concept does not appear to work at this point. Concentration should be on bringing top priority to the singular region. He reported that PROACT figures are in for the month and county residents continue to benefit greatly from the service. CJAC met today and there was a lot of information on the possible effects of increasing the age for youthful offenders increasing County costs across the board. In addition, there is a proposal under consideration to increase Leandra legislation to all DWI offenders effective upon arrest. Chair Hancock inquired about the Executive Order against unfunded mandates. This was issued under a previous administration and the State Legislature has not imposed it upon themselves. Legislator DeJaneiro stated the proposal to increase the age of juvenile offenders may have good intentions, but it is simply unaffordable. Legislator Bausch cited Deputy County Attorney Roger's revelation that when he volunteered to serve on the Committee considering this legislation to represent

western New York, he was told to just write a letter.

The meeting was adjourned at 8:10 PM upon motion of Legislator Lawrence seconded by Legislator Stein.
