TWELVETH DAY GENESEE COUNTY LEGISLATURE Wednesday, June 25, 2014 Byron, New York

The Genesee County Legislature met in Regular Session on Wednesday, June 25, 2014 at 5:30PM at the Town of Byron, 7028 Byron Holley Rd., Byron, New York as part of an outreach meeting. Prayer was offered by Legislator Lawrence, followed by the Pledge to the Flag.

In addition to the regular meeting Chairman Cianfrini opened a Public Hearing on the proposed budget for the Genesee Community College for the fiscal year beginning September 1, 2014. The Budget for Genesee Community College for the year September 1, 2014 through August 31, 2015 is \$38,700,000 with Genesee County's proposed share as sponsor in the amount of \$2,286,374. There were no speakers.

The minutes of the June 11, 2014 meeting were approved upon motion of Legislator Stein seconded by Legislator Lawrence.

Chairman Cianfrini thanked the Town of Byron for allowing the Legislature to hold their Legislature Meeting at their town building. Legislator Bausch presented Town of Byron Supervisor Yasses with a County Plague.

Legislator Stein reported that the recent InterCounty meeting was hosted by Finger Lakes Community College at the Victor Campus. FLCC has taken a page out of Genesee Community College's book and they have addressed a direct need to their economic base which is the Finger Lakes Wineries. They have started a program that is all about production vineyards. Mrs. Stein stated that the value we learn from our Community Colleges is that they are nimble and they can adapt very quickly to the economy that supports their base. Mrs. Stein appreciates how our local community college has adapted to the needs to agriculture and the agriculture engine.

Legislator Bausch attended the Genesee Finger Lakes Regional Planning Council, and at that meeting former Genesee County Legislator Willie Brooks, who has had a seat on this council for thirty plus years, has decided to step down. The appreciation the members of Genesee Finger Lakes Regional Planning Council showed Mr. Brooks for his service was overwhelming.

Legislator DeJaneiro reported that the Governor's Office will be holding a Citizen Emergency Preparedness seminar at Genesee Community College on June 30th at 5:30 PM. This will be a short session for citizens on how they should prepare for natural disasters in our area. This session is free and you must pre-register.

Legislature Clerk Kingdon shared a letter from Assemblyman Hawley in regards to the County's opposition to the Clean Water Act. Assemblyman Hawley stated in his letter that he too opposes this expansion and that this over-regulation will not only cause unnecessary financial hardship to farmers but will ultimately be passed on to consumers as well.

Legislator Stein commented that the Soil and Water Conservation District Entities will meet the new Agriculture Commissioner on July 7th at the Glenn Iris Inn at Letchworth State Park.

The Clerk proceeded with the reading of the resolutions as follows:

RESOLUTION NO. 218 CONTRACT - GLOW SOLID WASTE MANAGEMENT COMMITTEE /HOUSEHOLD HAZARDOUS WASTE COLLECTION-APPROVAL OF

Legislator DeJaneiro offered the following resolution:

WHEREAS, The GLOW Region Solid Waste Management Committee (herein referred to as "GLOW") anticipates being awarded funding from the New York State Department of Environmental Conservation in 2014 for Household Hazardous Waste Collection Program; and

WHEREAS, This funding is to be used to pay for eligible expenses at a single collection planned for September of 2014; and

WHEREAS, An RFP (Request for Proposals) was issued and five prospective vendors submitted proposals; and

WHEREAS, The GLOW Region Solid Waste Committee does recommend Environmental Enterprises, Inc. for award of the contract for the 2014 HHW Collection Program. Now, Therefore Be It

RESOLVED, That the Genesee County Legislature authorizes the Chairperson to enter into this contract with the other GLOW Counties and Environmental Enterprises, Inc. for the GLOW Household Hazardous Waste Collection Program at a cost not to exceed \$29,575.

Budget Impact Statement: Funds are available in the 2014 GLOW Budget for this expense and are in line with past expenditures. GLOW has applied for and expects to receive the NYS DEC Grant the HHW Collection that will cover one-half of "eligible" expenses.

Legislator Lawrence seconded the resolution which was adopted by 298 votes, Legislator Clattenburg (28) absent.

RESOLUTION NO. 219 GRANT APPLICATION/BUDGET AMENDMENT-GENESEE COUNTY AGRICULTURAL AND FARMLAND PROTECTION PLAN UPDATE – APPROVAL OF

Legislator Lawrence offered the following resolution:

WHEREAS, Genesee County's 13 year-old Agricultural and Farmland Protection Plan is in need of updating in order to support and enhance Genesee County's No. 1 industry, agriculture, and

WHEREAS, The New York State Department of Agriculture and Markets has made available up to \$50,000 of grant funds towards \$100,000 projects with a 50% local match in order to update County Agricultural and Farmland Protection Plans older than 10 years-old, and WHEREAS, The Genesee County Department of Planning, Office of Real Property, Cornell Cooperative Extension, and Soil and Water Conservation District Office have agreed to provide in-kind services for up to \$38,000 combined, and

WHEREAS, The Genesee County Agricultural and Farmland Protection Board recommended the approval of this grant application at its June 9, 2014 meeting, and

WHEREAS, The Committees on Public Service and Ways and Means did review this request and do recommend approval at this time, and

RESOLVED, That the Chairperson of the Genesee County Legislature is hereby authorized to approve the grant application as prepared by the Genesee County Department of Planning and approve the grant offer immediately upon receipt.

RESOLVED, The Genesee County Treasurer is hereby authorized and directed to amend the 2014 budget by increasing A.1000.1081 (other-payt in lieu of tax) by \$12,000 offset by an increase in a like amount to A.8020.4600.0000 (Contracted Services), and Be it further

RESOLVED, That the execution of this resolution is contingent on receiving the New York State Department of Agriculture and Markets' grant offer.

Budget Impact: State aid of \$50,000 and County cash match share of \$12,000. The County share will be funded from revenue produced from payments in lieu of taxes.

Legislator Stein seconded the resolution which was adopted by 326 votes.

RESOLUTION NO. 220 APPOINTMENT-GENESEE COUNTY PLANNING BOARD-APPROVAL OF

Legislator Bausch offered the following resolution:

WHEREAS, An application has been received from Virginia B. Adams of Bergen, New York indicating an interest and desire for appointment to the Genesee County Planning Board, and WHEREAS, The Committees on Public Service and Ways & Means do recommend that an appointment be made at this time. Now, therefore, Be it

RESOLVED, That the Genesee County Legislature does hereby appoint Virginia B. Adams of Bergen, New York to the Genesee County Planning Board to serve a term effective immediately through June 24, 2017.

Legislator Torrey seconded the resolution which was adopted by 326 votes.

Prior to roll call on the above resolution Legislator Bausch stated that he has known Ms. Adams for a number of years from her time on the GCC Board and Village of Bergen Board. She will do a great job on the Planning Board.

RESOLUTION NO. 221 BUDGET AMENDMENT – HISTORY DEPARTMENT / HISTORICAL MARKERS FUNDING-APPROVAL OF

Legislator Stein offered the following resolution:

WHEREAS, The County Historian has received funding from the William G. Pomeroy Foundation Historical Marker Fund Grant to purchase two historical markers in the amount of \$2,100, and

WHEREAS, The County Historian did request the funds be incorporated into the current operating budget to provide for the purchase of the two historical markers and mounting poles, and

WHEREAS, The Committees on Human Services and Ways and Means did review this request and do recommend approval at this time. Now, therefore, Be it

RESOLVED, That the Genesee County Treasurer is hereby authorized and directed to amend the 2014 Genesee County Budget for the History Department by increasing Appropriation A7510 – 4700.0000 Specialized Supplies in the amount of \$2,100; to be offset by an increase in Revenue A7510 2091 County Historian Charges in the amount of \$2,100.

Budget Impact: Increase of \$2,100 to the 2014 budget for the History Department. Funding was provided through the William G. Pomeroy Foundation Historical Marker Fund Grant. Funding not used as outlined within the award will be returned to the William G. Pomeroy Foundation Historical Marker Fund.

Legislator DeJaneiro seconded the resolution which was adopted by 326 votes.

RESOLUTION NO. 222 BUDGET TRANSFER - PUBLIC DEFENDERS OFFICE – APPROVAL OF

Legislator Clattenburg offered the following resolution:

RESOLVED, The Genesee County Highway Superintendent is hereby authorized and directed to purchase the man lift from United Rentals, 1601 Lyell Avenue, Rochester, NY for \$46,996 to be paid from Capital Project, 1% Sales Tax through Resolution #2014-50 adopted on February 12, 2014.

Budget Impact: Capital Project, 1% Sales Tax, was established for this purchase with Resolution #2014-50 Legislator Clattenburg seconded the resolution which was adopted by 326 votes.

RESOLUTION NO. 225 AWARD OF BID-HIGHWAY/FUEL FARM REPLACEMENT –APPROVAL OF

Legislator Torrey offered the following resolution:

WHEREAS, Genesee County advertised a bid to remove the existing underground tanks at the County Highway garage and replace the fuel system with above ground tanks, product readers, tank monitoring system and a new fuel canopy, and

WHEREAS, The Superintendent of Highways recommends awarding the bid to the lowest responsible bidder meeting County specifications for equipment, and

WHEREAS, The Committees on Public Service and Ways and Means did review this recommendation and do concur. Now, therefore, Be it

RESOLVED, That the Chairperson of the Genesee County Legislature is hereby authorized to enter into an agreement with LaValley Bros. Construction Inc., 10643 Ridge Road, Wolcott, New York 14590 in the amount of \$450,580.00.

Budget Impact Statement: A Capital Project for \$500,000 has been established. The bid was \$49,420 lower than the capital project established for this project.

RESOLUTION NO. 236 HOLD HARMLESS AGREEMENT-TOWN OF DARIEN/DARIEN RADIO TOWER-APPROVAL OF

WHEREAS, Genesee County did construct a radio tower pursuant to Resolution No. 93-2013 as part of the upgrade to the radio system, and

WHEREAS, Genesee County was immune from zoning requirements of the Town of Darien in regards to said radio tower, and

WHEREAS, The Town of Darien has requested that the County enter in an agreement holding the Town of Darien harmless from all damages resulting from the construction and maintenance of said radio tower, and

WHEREAS, The County Attorney has recommended that the County agree to hold the Town of Darien harmless for any said damages. Now, therefore, Be it

RESOLVED, That the Chairman of the Genesee County Legislature is hereby authorized and directed to enter into a hold harmless agreement with the Town of Darien for all damages resulting from the construction and maintenance of the radio tower located at 10569 Alleghany Road, Darien Center, New York and subject to approval as to form by the County Attorney. Legislator DeJaneiro seconded the resolution which was adopted by 326 votes.

Prior to roll call on the above resolution Legislator Lawrence thanked County Attorney Zambito

for his patient work on this matter.

RESOLUTION NO. 238 2014-2015 OPERATION BUDGET-GENESEE COMMUNITY COLLEGE/SPONSOR'S SHARE-ADOPTION OF

Legislator Bausch offered the following resolution:

WHEREAS, The President and Trustees of Genesee Community College have presented to the Genesee County Legislature the proposed operating budget of Genesee Community College for the academic year 2014-2015 in the amount of \$38,700,000, and

WHEREAS, The Board of Trustees and the Genesee County Legislature have approved the amount of \$2,286,374 as the sponsor's share of the proposed current operating budget for Genesee Community College. Now, therefore, Be it

RESOLVED, That the Genesee County Legislature does hereby approve of the proposed 2014/2015 operating budget of the Genesee Community College in the amount of \$38,700,000 for academic year 2014-2015, and Be it further

RESOLVED, That the Genesee County Legislature does hereby approve of the sponsor's share of the operating budget of the Genesee Community College for the fiscal year September 1, 2014 through August 31, 2015 in the amount of \$2,286,374 and cause the same to be included in the County Tax levy for the year 2015.

Legislator Stein seconded the resolution which was adopted by 283 votes, Legislator Lawrence (43) no.

Prior to roll call on the above resolution Legislator Lawrence stated that she will be voting no on this resolution. As she stated at the Ways and Means meeting she wishes that the request from the Community College would have come at a more timely matter, and that their request for a \$500,000 increase came less than 30 days prior to approving this budget. Legislator Ferrando commended the

College and the Legislature for holding down revenue over the past years. The College and their Board has done a good job keeping cost down over the years.
