Wednesday, October 12, 2016

The Genesee County Legislature met in Regular Session on Wednesday, October 12, 2016 at 5:30PM at the Old County Court House, Batavia, New York. Legislator Torrey assisted with the audit. Prayer was offered by Legislator Bausch followed by the Pledge to the Flag.

The minutes of the September 28, 2016 Legislature meeting were approved upon motion of Legislator Stein seconded by Legislator Bausch carried unanimously.

Legislator Stein reported she attended the Annual RSVP recognition lunch hosted by the Office for the Aging and noted the thousands of hours Genesee County senior citizens volunteer at various locations. She commended OFA Director Spink for the time and effort she and her staff put into the RSVP Program. Legislator Stein stated the Inter County meeting in October is hosted by Genesee County at Mercy Grove in LeRoy on October 21, 2016. Cost is \$20 and reservations are due to Clerk LaGrou by 10/14/16. Chair Cianfrini will provide a welcome along with two guest speakers scheduled to speak before lunch. Chair Cianfrini commented the incoming County Attorney Kevin Earl was present and is slated to take office January 1, 2017.

The Clerk proceeded with the resolutions:

RESOLUTION NO. 366 CONTRACT- HEALTH DEPARTMENT/PRESCHOOL SUPPORTIVE HEALTH SERVICES PROGRAM – APPROVAL OF

Legislator Stein offered the following resolution:

WHEREAS, The Public Health Director did present a contract for the provision of related services to eligible children in the Preschool Supportive Health Services Program, and **WHEREAS**, The Committee on Human Services did review the request and does recommend approval at this time. Now, therefore, Be it

RESOLVED, That the Chair of the Genesee County Legislature is hereby authorized and directed to execute a contract with Cantalician Center for Learning, 2049 George Urban Boulevard, Depew, NY 14043 for the provision of **Related Services** in the Preschool Supportive Health Services Program (PSSHSP) for the period September 1, 2016 through June 30, 2017 per the 2015-2017 PSSHSP rate schedule.

Budget Impact: Revenue and expenses are included in the 2016 A 2960 3-5 Preschool Program Budget and will be included in the 2017 Program Budget. These services qualify for NYS reimbursement at the rate of 59.5% less any Medicaid payment on Medicaid eligible children.

WHEREAS, The Public Health Director did present a request for extension of Paratransit Services for Children with Disability for Genesee and Orleans County Health

Departments, RFP 2013-112 contract, for the period October 1, 2016 through October 31, 2016 to ensure smooth and continued client service transition to Student Transport Inc. (DBA: WNY Bus Co.) resultant from RFP 2016-109 award, and

WHEREAS, Both parties agree to extend the contract for an additional one month period, upon mutual written agreement between both parties and under the same conditions as the original Agreement, and

WHEREAS, The Committee on Human Services did review this recommendation and does concur. Now, therefore, Be it

Budget Impact: Estimated annual expenses in the 2016 A 2960 Preschool Supportive Health Services budget are \$250,000. These services qualify for NYS reimbursement at the rate of 59.5% less any Medicaid payment for Medicaid eligible children.

Budget Impact: Estimated annual expenses in the 2016 A4059 Early Intervention budget are \$40,640. Expenses are offset, up to 100% by revenue generated from Medicaid. New York State is liable for 49% of any non-reimbursed expenditure.

Budget Impact: Estimated annual expenses in the 2013 A 4059 Early Intervention budget are \$43,000. Expenses are offset, up to 100% by revenue generated from Medicaid. New York State is liable for 49% of any non-reimbursed expenditure.
